#### **MODE OF MEETING**

In view of the COVID-19 outbreak and as part of the safety measures, the Thirtieth Annual General Meeting (the "30<sup>th</sup> AGM" or "AGM") of Media Chinese International Limited ("the Company" or "MCIL") will be conducted **fully virtual at the Broadcast Venue in Malaysia**. This is in line with the Guidance Note on the Conduct of General Meetings for Listed Issuers issued by the Securities Commission Malaysia on 24 June 2020 (including any amendment that may be made from time to time) ("Guidance Note").

The Broadcast Venue is strictly for the purpose of complying with Section 327(2) of the Companies Act 2016 and Guidance Note which require the Chairman of the meeting to be present at the main venue of the meeting. **NO MEMBERS/PROXIES/CORPORATE REPRESENTATIVES WILL BE ALLOWED TO BE PHYSICALLY PRESENT** at the Broadcast Venue in Malaysia on the day of the 30th AGM.

## REMOTE PARTICIPATION AND VOTING FACILITIES ("RPV")

Members are to attend, speak (including posing questions to the Board via real time submission of typed texts) and vote (collectively, "participate") remotely at the 30<sup>th</sup> AGM using RPV provided by Tricor Investor & Issuing House Services Sdn. Bhd. ("Tricor") via its **TIIH Online** website at <a href="https://tiih.online">https://tiih.online</a>.

Members who appoint proxies to participate via RPV in the 30<sup>th</sup> AGM must ensure that the duly executed proxy forms are deposited in a hard copy form or by electronic means to Tricor no later than **Monday**, **24 August 2020 at 10.00 a.m.** 

Corporate representatives of corporate members must deposit their original or duly certified certificate of appointment of corporate representative to Tricor not later than **Monday**, **24 August 2020 at 10.00 a.m.** to participate via RPV in the 30<sup>th</sup> AGM.

Attorneys appointed by power of attorney are to deposit their power of attorney with Tricor not later than **Monday**, **24 August 2020** at **10.00 a.m.** to participate via RPV in the 30<sup>th</sup> AGM.

A member who has appointed a proxy or attorney or authorised representative to participate at this 30<sup>th</sup> AGM via RPV must request his/her proxy to register himself/herself for RPV at TIIH Online website at https://tiih.online.

As the 30<sup>th</sup> AGM of MCIL (in Malaysia) is a fully virtual AGM, members who are unable to participate in this 30<sup>th</sup> AGM may appoint the Chairman of the meeting as his/her proxy and indicate the voting instructions in the proxy form.

## GENERAL MEETING REGISTER OF MEMBERS AND RECORD OF DEPOSITORS ("ROD")

For the purpose of the annual general meeting, the register of members in Hong Kong will be closed on **Tuesday**, **18 August 2020 to Wednesday**, **26 August 2020**, both days inclusive, during which no transfer of shares will be registered.
