MODE OF MEETING

As a result of the implementation of the FMCO, the Securities Commission Malaysia had revised the Guidance Note and FAQs on the conduct of General Meetings for Listed Issuers (the "Revised Guidance Note and FAQs") stated that with effective from 1 June 2021, any general meeting conduct during FMCO, is only allowed to conduct a fully virtual general meeting where all meeting participants including the Chairperson of the meeting, board members, senior management and members are required to participate in the meeting via online. Physical gatherings are strictly prohibited regardless of the crowd of any size.

REMOTE PARTICIPATION AND VOTING ("RPV") FACILITIES

Members are to attend, speak (including posing questions to the Board via real time submission of typed texts) and vote (collectively, "participate") remotely at the 31st AGM using RPV Facilities provided by Tricor Investor & Issuing House Services Sdn. Bhd. (the "Share Registrar" or "Tricor" or "TIIH") via its **TIIH Online** website at https://tiih.online.

Members who appoint proxies to participate via RPV Facilities in the 31st AGM must ensure that the duly executed proxy forms are deposited in a hard copy form or by electronic means to Tricor not later than **Monday, 23 August 2021 at 10.00 a.m.**

Corporate representatives of corporate members must deposit their original or duly certified certificate of appointment of corporate representative to Tricor not later than **Monday**, **23 August 2021 at 10.00 a.m.** to participate via RPV in the 31st AGM.

Attorneys appointed by power of attorney are to deposit their power of attorney with Tricor not later than **Monday**, **23 August 2021 at 10.00 a.m.** to participate via RPV in the 31st AGM.

A member who has appointed a proxy or attorney or authorised representative to participate at this 31st AGM via RPV Facilities must request his/her proxy or attorney or authorised representative to register himself/herself for RPV at TIIH Online website at https://tiih.online.

As the 31st AGM of Media Chinese International Limited ("MCIL") is a fully virtual AGM in Malaysia, members who are unable to participate in this 31st AGM may appoint the Chairman of the meeting as his/her proxy and indicate the voting instructions in the Proxy Form.

If you are already a user with TIIH Online, you are not required to register again. You will receive an e-mail to notify you that the remote participation is available for registration at TIIH Online. 			
(b)	Submit your request to attend 31st AGM remotely	 Registration is open from 10.00 a.m. Tuesday, 27 July 2021 until the day of 31st AGM, Wednesday, 25 August 2021. Member(s) or proxy(ies) or corporate representative(s) or attorney(s) are required to pre-register their attendance for the 31st AGM to ascertain their eligibility to participate the 31st AGM using the RPV. Login with your user ID and password and select the corporate event: "(REGISTRATION) MEDIA CHINESE 31ST AGM". Read and agree to the Terms & Conditions and confirm the Declaration. Select "Register for Remote Participation and Voting". Review your registration and proceed to register. System will send an e-mail to notify that your registration for remote participation is received and will be verified. After verification of your registration against the General Meeting Record of Depositors as at 18 August 2021, the system will send you an e-mail after 23 August 2021 to approve or reject your registration for remote participation. (Note: Please allow sufficient time for approval of new user of TIIH Online and registration for the RPV).

(d)	Participate through Live Streaming	 Select the corporate event: "(LIVE STREAM MEETING) MEDIA CHINESE 31ST AGM" to engage in the proceedings of the 31st AGM remotely. If you have any question for the Chairman/Board, you may use the query box to transmit your question. The Chairman/Board will 			

		endeavour to respond to questions submitted by remote participants during the 31st AGM. If there is time constraint, the responses will be e-mailed to you at the earliest possible, after the meeting.
(e)	Online Remote Voting	 Voting session commences from 10.00 a.m. on Wednesday, 25 August 2021 until a time when the Chairman announces the completion of the voting session of the 31st AGM. Select the corporate event: "(REMOTE VOTING) MEDIA CHINESE 31ST AGM" or if you are on the live stream meeting page, you can select "GO TO REMOTE VOTING PAGE" button below the Query Box. Read and agree to the Terms & Conditions and confirm the Declaration. Select the CDS account that represents your shareholdings. Indicate your votes for the resolutions that are tabled for voting. Confirm and submit your votes.
(f)	End of remote participation	Upon the announcement by the Chairman on the closure of the 31st AGM, the live streaming will end.

Note to users of the RPV Facilities:

- 1. Should your registration for RPV be approved, we will make available to you the rights to join the live streamed meeting and to vote remotely. Your login to TIIH Online on the day of meeting will indicate your presence at the virtual meeting.
- 2. The quality of your connection to the live broadcast is dependent on the bandwidth and stability of the internet at your location and the device you use.

PRE-MEETING SUBMISSION OF QUESTION TO THE BOARD OF DIRECTORS

ENTITLEMENT TO PARTICIPATE / GENERAL MEETING RECORD OF DEPOSITORS ("ROD")

Only a depositor whose name appears on the ROD as at **18 August 2021** shall be entitled to attend, speak (including posing questions to the Board via real time submission of typed texts) and vote (collectively, "participate") remotely at the 31st AGM or appoint proxies/corporate representatives/attorneys to participate remotely on their behalf.

APPOINTMENT OF PROXY / CORPORATE REPRESENTATIVES / ATTORNEYS

The 31st AGM will be conducted on a fully virtual basis via TIIH Online Platform, if you are unable to participate the meeting via RPV on 25 August 2021, you may appoint the Chairman of the meeting as proxy and indicate the voting instructions in the Proxy Form.

POLL VOTING

The Voting at the 31st AGM will be conducted by poll in accordance with Paragraph 8.29A of Bursa Malaysia Securities Berhad Main Market Listing Requirements and Rule 13.39(4) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

Members can proceed to vote on the resolutions at any time from the commencement of the 31st AGM at 10.00 a.m. but before the end of the voting session which will be announced by the Chairman of the Meeting. Kindly refer to the note above, "Procedures for RPV Facilities" for guidance on how to vote remotely from **TIIH Online** website at https://tiih.online.

Upon completion of the voting session for the 31st AGM, the Scrutineers will verify the poll results followed by the Chairman to declare whether the resolutions are duly passed.
